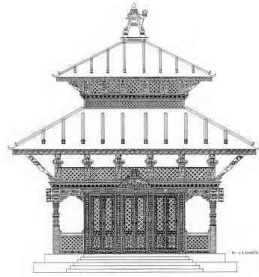

3. The objects of the association  
A historical, administrative, and social commemorative incorporated association
  - gathering
  - promoting
  - archiving
  - knowledge, contacts, and resources pertaining to the Nepalese Peace Pagoda, and World Expo '88, for the City of Brisbane
  - creating
  - establishing
  - maintaining
  - a World Expo '88 Commemorative Museum at the Nepalese Peace Pagoda, for all time, with membership a pre-requisite for volunteer management and staff
  - leading
  - representing
  - speaking
  - for the Nepalese Peace Pagoda and World Expo '88 at an internet, local, state, national and international level
  - via thrice-yearly meetings, and the Annual General Meeting
  - via a commemorative web-presence at <http://www.foundationexpo88.org/friendsofthepagoda/>

- via a topical and timely presence in the mass media, local newspapers, magazines, and websites, as well as contact with government and non-government arts and other organisations and individuals
